Dear Sir,

We are writing to you regarding the redevelopment of our society. This step is a a once in a lifetime time step and requires a well thought out decision at each of the phases.

Selection and appointment of the project management consultant it is one of the most important as they will be our representatives to safeguard our interests and make sure that we get the best deal possible from the developer/builder and also that the building does not flout any BMC rules and regulations.

In the SGM held on Sunday two days ago there was no informed consent or informed decision.

Members were only told that 6 quotations had been received of which two had been discarded. They were then told that the managing committee had recommended one name. The reason for or the two quotations being discarded were not disclosed. Also, the comparative statements of the four remaining PMCs were not presented at all. It was expected that each of the four remaining contenders would be classified on the basis of their years of experience, number of projects undertaken, number of projects successfully completed within the stipulated time. This should have been given to members to study to voice their opinions. We also feel that the completed projects and partially completed projects could have been visited and some members staying in the completed society buildings asked for their experience with the PMC's prompt on time delivery. transparency and help at every stage to the members of the society.

We therefore ask you and urge you to circulate the comparative statement of each of the quotations namely all the six after an adequate period of maybe 5 to 7 days, reconvene an SGM to take an informed decision.

You will recall when the repairs were undertaken a few years ago the members were taken into confidence at every stage.

This is the best interest of transparency which should always be seen to be transparent. We would not like at a later stage accusations to be bandied about. You will agree that past experience shows that when there is less transparency, later on there are ill feelings within our fraternity. We do not want at any stage the credentials of the Managing committee members to be questioned.

We would also urge the managing committee to make the redevelopment committee more broad-based and take 2-4 ordinary members who are willing to positively work towards a smooth and non- contentious redevelopment.
